

# POLICY COMMITTEE MEETING MINUTES March 21, 2022 – 5:30 p.m. Waupaca High School Community Room and Live Stream

### Welcome and Call to Order:

The meeting was called to order by Committee Chairperson Patrick Phair at 5:30 p.m.

#### **Roll Call:**

Present in the WHS Community Room: All members of the Committee were present (Chairperson Patrick Phair and Steve Klismet; Mark Polebitski arrived at 5:32 p.m.). Additionally, Board members Stephen Johnson, Dale Feldt, and Steve Hackett were present; Betty Manion was present via phone.

## **Approval of Agenda:**

A motion was made by Steve Klismet and seconded by Patrick Phair to approve the agenda as presented. The motion carried unanimously on a voice vote.

#### **Review of Board Meeting Norms:**

The Board reviewed their collective commitments.

Review Bullying Policy (NEOLA Policy 5517.01 Bullying and NEOLA Policy 5517 Student Anti-Harassment), and Non Discrimination Policy (NEOLA Policies 1422, 3122, and 4122 Nondiscrimination and Equal Employment Opportunity, NEOLA Policy 2260 Nondiscrimination and Access to Equal Educational Opportunity, and NEOLA Policy 2266 Nondiscrimination on the Basis of Sex in Education Programs or Activities):

Committee Chairperson Patrick Phair advised that he asked to review these policies due to what he had learned at the recent School Law Conference, particularly with regard to the bullying policy – that the motive behind the bullying is not important but what is important is the victim's perception of the act(s); that bullying policies shouldn't indicate that there has to be an intentional act behind the bullying; and even if the complaint comes in anonymous, it needs to be investigated.

Director of Student Services Laurie Schmidt agreed that it is about the perception of the individual being bullied. She stated that our policies are good and wouldn't recommend any edits. She also advised that if the Committee has any legal questions or requested edits, they should be directed to NEOLA for their review.

Mr. Phair noted that the Title IX Compliance Officers and their addresses are listed in our bullying and nondiscrimination policies as is required.

The Committee and Ms. Schmidt agreed that our current policies are in good standing, adding that when there's a breakdown, it is because the school district didn't follow their own policies.

Committee member Steve Klismet suggested that perhaps better communication regarding the District's bullying policy should be provided to the parents other than it being in the handbooks. Committee Chairperson Phair suggested that we could remind people of the bullying policy at our upcoming regular Board meeting on April 12.

Some discussion was had regarding the development of an information program and how that differs from what we are doing now. The Committee concluded that it is important to market our District but we can do so by continuing with what we are currently doing.

Board member Dale Feldt suggested that perhaps this policy should be posted at all events. In addition, Committee Chairperson Phair noted that the language found in the last paragraph of this policy needs to be included on all notices and other communications about school and Board events.

Much discussion was had regarding whether a new parent organization should be required to obtain final approval by the Board as a prerequisite to organizing. The Committee was reminded that this is not for student groups or their parents, but only for parent groups. Committee member Mark Polebitski ultimately withdrew his concerns, and the Committee decided to keep the policy as is.

District Administrator Ron Saari advised that the District has a corporate membership with the Rotary Club and we have three administrators who are currently members. Committee Chairperson Phair asked that the District make sure that there is a representative in the Rotary Club every year.

Mr. Saari advised that NEOLA doesn't have anything regarding these three Waupaca policies, so it is up to the Committee/Board if it still wants to keep them. Committee member Mark Polebitski felt that they are antiquated and suggested that they be removed. Much discussion then ensued, with some Board members agreeing that perhaps the policy relating to speed limits could be removed because that is set by state law. However, several Board members felt that the policies pertaining to bulletin boards and circulating petitions should remain. After further discussion, the Committee tabled these three policies for further consideration and discussion at a later date.
