

SCHOOL BOARD MEETING MINUTES MARCH 13, 2018 Regular Meeting

Pursuant to the regulations, the regular board meeting was held on the above date in the Waupaca High School Community Room.

President's Comments and Pledge of Allegiance:

Stephen Johnson welcomed everyone and asked Teresa Duda to lead the Board in the Pledge of Allegiance.

Call to Order:

The meeting was called to order by President Stephen Johnson at 5:15 p.m.

Roll Call:

Present: All board members present except Steven Johnson.

Approval of Agenda:

A motion was made by Sandra Robinson and seconded by Dmitri Martin to approve the agenda with items IX.B.4.a&b – Preliminary Non-Renewals being pulled from the consent agenda and moved to VIII.D.5 (immediately preceding the consent agenda). Motion passed unanimously on a voice vote.

Mr. John Laedke, Mr. Thomas Miller and Ms. Nancy Miller addressed the Board voicing their concerns over the proposed preliminary non-renewal of Mr. Janssen.

Approval of Minutes:

Community Partnership & Recognition:

It was noted that March 5-9, 2018 was National School Breakfast Week.

District Administrator's Report:

Dr. Nyen noted several items: 1) after review of several candidates a team of stakeholders including students, parents, staff and administration interviewed three highly qualified candidates and recommended hiring of Mike Werbowsky; 2) in the wake of recent events regarding school safety, State Representative Sondy Pope has circulated a group of bills call Wisconsin Student Safety Package; 3) with the one month anniversary of tragic loss of life in Parkland, Florida and the national efforts underway to engage students in protest – administration asks that students and community members respect the rights of those who wish to remain in the classroom and not be disruptive to the learning environment; 4) Waupaca Breakfast Rotary Club sponsored the fundraiser *Casino Royale* on February 16th and realized a 30% increase in donations. More than \$9000 were raised to support the efforts of rotary – one of which is education; 5) Retired Director Michael George was present recently to hear our 8th grade band and choir perform and he penned a letter to the Middle School staff complementing them on their performances; 6) one-year reunion of the event referred to as #WaupacaWay2k30 is scheduled for Thursday, April 26th from 5:30 – 8:30 p.m.; and 7) congratulations to our Chain Exploration Center Leadership team on the completion of the Charter School Grant Application.

Board Monitoring:

Special Education: Maureen Markon gave an overview of the data on indicators 9 & 10 regarding disproportionate representation of racial and ethnic groups and noted that while our district scored well over-all, she did have some areas that stood out and would be focused on when reviewing our current intervention processes. Ms. Drankus reviewed the recently implemented Early Intervention Services through the Pyramid Model. She explained the program and how it will be utilized throughout all of our Early Childhood and 4K sites.
