MS Roof Project:

A motion was made by Patrick Phair and seconded by Elizabeth Manion to approve the MS roofing project at a cost not to exceed \$166,766 for labor from Weinert Roofing and \$92,224 for supplies from ABC Supply. The motion carried unanimously on a voice vote. It was noted by Mr. Hayek that there are a few other roof issues throughout the district such as the High School and Chain that will be done either in-house or contracted out but those will be at a cost that will not require Board action.
