**Re:** Student Academic Standards

## **Background**

Wisconsin 2015 Act 55, sections 118.30(1g)(a)1 and 120.12(13), require school boards to identify the student academic standards in mathematics, science, reading and writing, geography, and history, adopted by the board. In addition, school boards are required by state statute to notify parents/guardians of students enrolled in the school district of the student academic standards that will be in effect for the school year. Boards must provide this notice annually prior to the beginning of the school term. The notice may be provided electronically, including by posting the notice or a link to the specific academic standards on the district's website.

Additionally, with regards to emphasizing content-area literacy in all subjects, Wisconsin and The School District of Waupaca have adopted the Common Core State Standards for Disciplinary Literacy. Two other important notices regarding the academic standards used by our School District of Waupaca Staff:

- Certain upper level courses, whose content is dictated by another entity, such as: Advanced Placement (AP), UW-Oshkosh Cooperative Academic Partnership Program (CAPP), Fox Valley Technical College Start College Now Courses, may require us to use other standards to meet course expectations. These other standards may come from a combination of state, national, industry, university, and/or certification standards.
- Starting with the 2022-23 school year, courses taught within the School District of Waupaca use Learning Targets to guide and communicate to students and parents what we expect our students to know and be able to do. Learning Targets have been created by our teachers to increase the clarity of the standards, and thus our learning expectations. Each Learning Target will include a notation related to the standard in which it was created from. For example:
  - A fourth grade English Language Arts standard asks students to: Summarize texts, from a variety of genres, to determine a theme or central idea and explain how it is supported by key details (WI ELA Standards, 4.R.2).

- Our team of teachers broke this standard down into the following Learning Targets:
  - I am learning to summarize grade level texts (R.4.2(a)
  - I am learning to use key words to determine and explain a theme or central idea of a text (R.4.2(b)
- Learning Targets will be used in conjunction with success criteria and daily teaching objectives to ensure that our students meet the expectations of the standards.
