Only courses/programs that have received prior approval will be considered for salary adjustments. As noted on the Teacher Salary Matrix, teachers may earn and accumulate up to 30 graduate level credits that can be applied to their salary, but in order to move to Master + salary step (i.e. M+6), the graduate credits must be earned after receiving a master's degree. A copy of an official transcript or grade report must be attached to this form.
